An act to ~~add Article 1.6 (commencing with Section 118917) to Chapter 4 of Part 15 of Division 104~~ amend Section 104495 of the Health and Safety Code, relating to tobacco.

LEGISLATIVE COUNSEL'S DIGEST

SB 977, as amended, Pan. Tobacco: youth sports events.

*Existing law prohibits the smoking of a cigarette, cigar, or other tobacco-related product, and the disposal of tobacco-related waste, within 25 feet of any playground or tot lot sandbox area, as defined. Existing law prohibits a person from intimidating or retaliating against another person seeking compliance with these prohibitions. A violation of these prohibitions is an infraction, punishable by a fine of \$250 for each violation. Existing law expressly does not preempt the authority of any county, city, or city and county to regulate smoking around playgrounds or tot lot sandbox areas.*

*This bill would prohibit the use of a tobacco product, as defined, within 250 feet of a youth sports event, and make a violation an infraction punishable by a fine of \$250 for each violation. The bill would state that its provisions do not preempt the authority of any county, city, or city and county to regulate the use of tobacco products around a youth sports event. By establishing a new crime, this bill would create a state-mandated local program.*

*The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state.*

*Statutory provisions establish procedures for making that reimbursement.*

*This bill would provide that no reimbursement is required by this act for a specified reason.*

~~Existing law generally prohibits the smoking of tobacco in the workplace and in public buildings, except in specified areas.~~

~~This bill would prohibit the use of a tobacco product, as defined, within 250 feet of a youth sports event, as defined. The bill would make a violation of this provision a crime punishable by a \$100 fine. By establishing a new crime, this bill would create a state-mandated local program.~~

~~The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.~~

~~This bill would provide that no reimbursement is required by this act for a specified reason.~~

*The people of the State of California do enact as follows:*

1     SECTION 1. Section 104495 of the Health and Safety Code is  
2     amended to read:

3     104495. (a) For the purposes of this section, the following  
4     definitions shall govern:

5     (1) "Playground" means any park or recreational area  
6     specifically designed to be used by children that has play equipment  
7     installed, or any similar facility located on public or private school  
8     grounds, or on city, county, or state park grounds.

9     (2) "Tot lot sandbox area" means a designated play area within  
10    a public park for the use by children under five years of age. Where  
11    the area is not contained by a fence, the boundary of a tot lot  
12    sandbox area shall be defined by the edge of the resilient surface  
13    of safety material, such as concrete or wood, or any other material  
14    surrounding the tot lot sandbox area.

15    (3) "Public park" includes a park operated by a public agency.

16    ~~(4) "Smoke or smoking" means the carrying of a lighted pipe,  
17    lighted cigar, or lighted cigarette of any kind, or the lighting of a  
18    pipe, cigar, or cigarette of any kind, including, but not limited to,  
19    tobacco, or any other weed or plant.~~

1 (4) “Youth sports event” means any practice, game, or related  
2 activity organized by a nonprofit youth sports organization at  
3 which athletes up to 18 years of age are present.

4 (5) “Smoke or smoking” means inhaling, exhaling, burning, or  
5 carrying any lighted or heated cigar, cigarette, or pipe, or any  
6 other lighted or heated tobacco or plant product intended for  
7 inhalation, whether natural or synthetic, in any manner or in any  
8 form. “Smoking” includes the use of an electronic smoking device  
9 that creates an aerosol or vapor, in any manner or in any form,  
10 or the use of any oral smoking device for the purpose of  
11 circumventing the prohibition of smoking.

17 (A) A product containing, made, or derived from tobacco or  
18 nicotine that is intended for human consumption, whether smoked,  
19 heated, chewed, absorbed, dissolved, inhaled, snorted, sniffed, or  
20 ingested by any other means, including, but not limited to,  
21 cigarettes, cigars, little cigars, chewing tobacco, pipe tobacco, or  
22 snuff.

23 (B) An electronic device that delivers nicotine or other vaporized  
24 liquids to the person inhaling from the device, including, but not  
25 limited to, an electronic cigarette, cigar, pipe, or hookah.

26 (C) Any component, part, or accessory of a tobacco product,  
27 whether or not sold separately.

28 (b) ~~No~~A person shall *not* smoke a cigarette, cigar, or other  
29 tobacco-related product within 25 feet of any playground or tot  
30 lot sandbox area.

31 (c) ~~No~~A person shall *not* dispose of cigarette butts, cigar butts,  
32 or any other tobacco-related waste within 25 feet of a playground  
33 or a tot lot sandbox area.

34 (d) A person shall *not* use a tobacco product within 250 feet of  
35 a youth sports event.

37 (e) A person shall *not* intimidate, threaten any reprisal, or effect  
38 any reprisal, for the purpose of retaliating against another person

1 (f) Any person who violates this section is guilty of an infraction  
2 and shall be punished by a fine of two hundred fifty dollars (\$250)  
3 for each violation of this section. Punishment under this section  
4 shall not preclude punishment pursuant to Section 13002, Section  
5 374.4 of the Penal Code, or any other ~~provision of law~~ proscribing
